Comment on Figures:

 After an excellent first quarter, the company was not quite able to meet the forecasts in the second quarter. The half-year as a whole was nevertheless extremely strong.

The reasons for the somewhat weaker figures were the typical negative factors of the current economic environment: the war in Ukraine, high interest rates, and inflationary pressures burdening demand.

Data Modul was able to present yet another convincing quarter, although the momentum has subsided somewhat compared to the first quarter. Of particular significance for the future is the order backlog, which experienced a noticeable decline. The order intake in the second quarter amounted to EUR 63.5m, representing a decrease of 22.9% from the elevated level of the same period the previous year - which was strong due to catch-up effects.

Nonetheless, the order backlog stood at EUR 201.3m, a 3.0% increase over the previous year's level of EUR 195.5m. In view of this, a revision of the forecasts (WRe) appears appropriate (see below). The increased costs and interest rates have had an adverse impact, especially in the field of construction activities and related display technologies (white goods). Additionally, the lingering effects of the Ukraine conflict continue to weigh on demand.


However, overall, the company has a positive outlook and only slight adjustments seem appropriate from today's perspective. All in all, there are also positive aspects to the current situation, e.g. the availability of skilled workers has increased again.

The stock remains a Buy with an unchanged target price of EUR 98 (model roll-over).


